Purchase of a permit is a privilege. Students who have vehicles with valid parking permits should park in the designated parking lot. Parking is on a first come first served basis. There are limited spots available.

Rules and Regulations:

- Display valid parking permit on the windshield—passenger side
- School Security and faculty will monitor the parking lots for valid permits.
- Permits are issued to the student and vehicle and are NOT transferable to other students or vehicles.
- A separate card and sticker are necessary for each vehicle.
- Obey all traffic laws.
- Speed limit is 15 mph on school campus.
- Park in designated student parking only.
- Do not park in handicapped, fire lanes, visitor or staff parking, or loading areas.
- Use the most direct route off school property and do not circle the building

Student parking is a privilege and may be revoked at any time without refund for the following reasons:

- Truancy
- Excessive Tardies
- Abuse of parking privileges, rules and regulations
- Dangerous or reckless driving
- Violation of HAHS handbook, student code of conduct contract
- Reproduction of passes will result in the loss of pass.
- Loitering in the automobile or in the parking lot before, during, or after school.

DISCLAIMER
